A Helping Hand

At Catholic Charities, we see it every day: a mother facing an unexpected layoff, a neighbor falling behind on rent due to illness, or a family simply unable to keep up with rising inflation. Oftentimes, we can help. In extreme circumstances, however, Catholic Charities may not have the financial resources to meet someone's need in a lasting and sustainable way.

Thanks to FEASST, Catholic Charities and similar organizations can continue to welcome people with open arms, even in these extreme circumstances.

FEASST, or Family Emergency Assistance of Southern SaraToga County, is a unique network of community partners and human services providers that collaborate and work together to help people in need across Southern and Northern Saratoga County. The expansion to the northern half of the county came last year with the introduction of FEASST Northern Saratoga.

"So many people end up with us because they have nowhere else to go," said Maggie Norton, Community Navigator for Catholic Charities of Saratoga, Warren and Washington Counties and FEASST liaison. "They'll get SNAP, but they're not going get their card for another week and a half.



They have no food. What do you do?"

In cases like these, Community Navigators like Maggie meet with clients to address their needs in a long-lasting, sustainable way. In the event a sustainable solution can't be reached through financial assistance alone, Maggie may recommend additional support or refer the client to a different program or organization.

In case of extreme need, Catholic Charities can rely on other FEASST organizations to fill the gap to get a person back on their feet – and keep them there.

"If somebody has a couple thousand dollars back rent owed, none of our organizations that can do that alone," said Sister Charla Commins, Executive Director of Catholic Charities of Saratoga, Warren

and Washington Counties. "So, a client would call a certain agency and that organization does intake. Then, if it's deemed necessary and sustainable, that organization will get on the phone and call to say 'can you pitch in to help?' It's so much more manageable for agencies."

While newly formalized, the collaboration behind FEASST, has existed in practice for some time.

"For years we've had agency administrative meetings," said Sister Charla Commins. "People would be very open to seeing how we could coordinate services. The needs then began to escalate and none of us had enough money to be able to solve anybody's individual problems. And so the agencies said, how can we do this better?"

Through FEASST, Catholic Charities is helping people who otherwise may have been turned away, like Jennifer*

"Jennifer lived out in an apartment in the middle of Clifton Park. She has a lot of health issues, but doesn't have any family in the area," explained Maggie. "Her doctor said she really should try to move closer to where she could get medical transportation. She was able to get an apartment here in Saratoga, but needed a \$950 security deposit. And with the moving costs and everything, she couldn't afford that. So we got her help, thanks to FEASST."




